PROVIDING FOR A REINVESTMENT FRAMEWORK FOR REAL ESTATE INVESTMENT TRUST (REIT) SPONSORS OR PROMOTERS, AMENDING FOR THE PURPOSE SECTIONS 3, 8, AND 9 OF REPUBLIC ACT NO. 9856, OTHERWISE KNOWN AS "THE REAL ESTATE INVESTMENT TRUST (REIT) ACT OF 2009"

- Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:
- SEC. 1. Section 3 of Republic Act No. 9856, otherwise known as "The Real Estate Investment Trust (REIT) Act of 2009", is hereby amended to read as follows:

- 15 XXX REINVESTMENT PLAN SHALL 9.4 THE REIT SUBMIT 16 Α _ 17 REINVESTMENT PLAN TO THE EXCHANGE AND THE COMMISSION UPON REGISTRATION. FURTHER, THE REIT IS REQUIRED TO ANNUALLY 18 SECURE A CERTIFICATION FROM THE COMMISSION THAT IT IS 19 20 COMPLIANT WITH ITS REINVESTMENT PLAN. 21

- SEC. 4. If any provision of this Act shall be held unconstitutional or invalid, the other provisions 23 not otherwise affected shall remain in full force and effect. 24
- SEC. 5. All laws, decrees, executive orders, rules and regulations or parts thereof which are 25 contrary to or inconsistent with this Act are hereby repealed, amended or modified accordingly. 26
- SEC. 6. This Act shall take effect fifteen (15) days after its publication in the Official Gazette 27 28 or in a newspaper of general circulation.
